Recommended separation distance between portable and mobile RF communications equipment and the AD761f

The AD761f is intended for use in an electromagnetic environment (for home healthcare) in which radiated RF disturbances are controlled. The customer or the user of the AD761f can help prevent electromagnetic interference by maintaining a minimum distance between portable and mobile RF communications equipment (transmitters) and the AD761f as recommended below, according to the maximum output power of the communications equipment.
