Recommended separation distance between portable and mobile RF communications equipment and the $MW701\mathrm{f}$

The MW701f is intended for use in an electromagnetic environment (for home healthcare) in which radiated RF disturbances are controlled. The customer or the user of the MW701f can help prevent electromagnetic interference by maintaining a minimum distance between portable and mobile RF communications equipment (transmitters) and the MW701f as recommended below, according to the maximum output power of the communications equipment.

NOTE1: At 80 MHz and 800 MHz, the separation distance for the higher frequency range applies.
