<b>Recommended separation distance between portable and mobile RF communications equipment and the CF155f</b>			
The CF155f is intended for use in an electromagnetic environment (for home healthcare) in which radiated RF disturbances are controlled. The customer or the user of the CF155f can help prevent electromagnetic interference by maintaining a minimum distance between portable and mobile RF communications equipment (transmitters) and the CF155f as recommended below, according to the maximum output power of the communications equipment.
